2025 Fast Start Restart Official Rules

1. Eligibility

The 2025 Fast Start Restart Incentive (the "Incentive") is open only to Brand Ambassadors who are legal residents of Canada, Mexico, Australia, New Zealand, and the United States (including District of Columbia and Puerto Rico) who have reached the legal age of majority in their jurisdiction of residence at the time of entry. Void where prohibited by law. Employees of sponsor and their immediate families and household members are not eligible and may not participate in this contest. The contest is subject to all applicable federal, state, provincial, and local laws and regulations. Participation constitutes each entrant's full and unconditional agreement to be legally bound by these Official Rules and sponsor's decisions, which are final and binding (without right of appeal) in all matters related to the contest to the extent permitted by law. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Timing

The Incentive begins January 1, 2025, at 12:00 a.m. USA ET and ends May 31, 2025, at 11:59 p.m. USA ET (the "Incentive Period"). Sponsor is the official timekeeper for this Incentive.

4. How to Qualify

To qualify for Incentive prizes, Brand Ambassadors must:

- i) Be commission-qualified1;
- ii) Have a current Plexus Annual Membership;
- iii) Have at least 100 PV in the current month or be qualified in the prior month.

5. How to earn

From January 1-May 31, 2025, all commission-qualified Brand Ambassadors with a baseline highest achieved rank of Silver -- Senior Ruby (See Silver-Sr. Ruby Rank Qualification Table) in December 2024 will have an opportunity to earn their Fast Start Silver -- Senior Ruby Bonuses for a second time. They must have new qualified personal enrollments and generate new points to earn these bonuses again.

- •To earn **Fast Start Silver**, Brand Ambassadors will be required to generate **18 points** from new enrollments and their new downline's enrollments with a join date within the incentive timeframe and **3 new Level 1 VIP Customers or Brand Ambassadors** with an initial order of 100 PV+ to be qualified in the same month their 18 points are accrued and be paid as a Silver rank.
- •To earn **Fast Start Senior Silver**, Brand Ambassadors will be required to generate **50 points** from new enrollments and their new downline's enrollments with a join date within the incentive timeframe and **3 new Level 1 VIP Customers or Brand Ambassadors** with an initial order of 100 PV+ to be qualified in the same month their 50 points are accrued and be paid as a Senior Silver rank.
- •To earn **Fast Start Gold**, Brand Ambassadors will be required to generate **100 points** from new enrollments and their new downline's enrollments with a join date within the incentive timeframe and **3 new Level 1 VIP Customers or Brand Ambassadors** with an initial order of 100 PV+ to be qualified in the same month their 100 points are accrued and be paid as a Gold rank.
- •To earn **Fast Start Senior Gold**, Brand Ambassadors will be required to generate **250 points** from new enrollments and their new downline's enrollments with a join date within the incentive timeframe and **3 new Level 1 VIP Customers or Brand Ambassadors** with an initial order of 100 PV+ to be qualified in the same month their 250 points are accrued and be paid as a Senior Gold rank.

¹ Commission qualified is defined as: i) having your Plexus Annual Membership paid and current; ii) having at least 100 Personal Volume (PV) through the monthly cycle end date.

- •To earn **Fast Start Ruby**, Brand Ambassadors will be required to generate **500 points** from new enrollments and their new downline's enrollments with a join date within the incentive timeframe **and 4 new Level 1 VIP Customers or Brand Ambassadors** with an initial order of 100 PV+ to be qualified in the same month their 500 points are accrued and be paid as a Ruby rank.
- •To earn **Fast Start Senior Ruby**, Brand Ambassadors will be required to generate **750 points** from new enrollments and their new downline's enrollments with a join date within the incentive timeframe and **5 new Level 1 VIP Customers or Brand Ambassadors** with an initial order of 100 PV+ to be qualified in the same month their 750 points are accrued and be paid as a Senior Ruby rank.

Brand Ambassadors must finish a month with the new qualifying points to achieve a rank.

Each Fast Start Restart Bonus can only be earned once during the incentive timeframe.

As long as a Brand Ambassador is baseline rank eligible, meaning their highest achieved rank from December 2024 is less than Emerald, they are still eligible to earn a Fast Start Restart Bonus. Once they achieve a rank of Emerald or higher during the incentive timeframe, they are no longer eligible to participate in the Fast Start Restart.

Brand Ambassadors currently in their initial Fast Start timeframe do not qualify for this Incentive, as they are eligible to earn these bonuses for the first time.

Plexus Points. Plexus Points can be earned for each VIP Customer with 25 PV or more and Brand Ambassador with 50 PV or more in your team. The number of Points earned on each depends on their PV for the month and the position in your team (up to 7 pay levels down, depending on your rank). Each Point has a dollar value (Pay Point Value) based on the total commissions pool amount. Plexus Points earnings is determined by the number of Points earned for the month multiplied by the pay Point value.

All credit card payments must be in the name of the purchasing Brand Ambassador and VIP Customer and not that of the sponsor or upline. Any welcome pack purchases subject to returns, refunds, and declined eCheck payments will not generate any credits. Brand Ambassadors not in good standing under the Plexus policies and procedures are not eligible to participate in this Contest.

The sponsor's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision. In the event of any discrepancy or inconsistency between the terms and conditions of these Official Rules and disclosures or other statements contained in any contest-related materials, the terms and conditions of these Official Rules shall prevail, govern, and control.
