

The Fast Start Program is open to Brand Ambassadors residing in Mexico who are of legal age in their country of residence by January 1, 2021. Employees of Plexus Worldwide, LLC (the "Company" or "Plexus") and its respective subsidiaries, affiliates, and agents, as well as the immediate family (spouse, parents, siblings, and children) and the household members of each such person, are not eligible. The program is subject to all applicable federal, state, provincial, and local laws and regulations and is void where prohibited by law. Program participants are referred to as "you", "your" or "Participant".

Fast Start rank up Achievement Bonuses will be paid out the following qualifying month via HyperWallet, except for the Fast Start 30-Day Silver Achievement Bonus, which will be paid out when it's achieved in that weekly commission cycle before the 30-day time period has expired.
