Plexus® Product Subscription Terms and Conditions

Welcome to the terms and conditions ("Terms") for our Product Subscription ordering program ("Subscription"). These Terms are between you ("You") and Plexus Worldwide, LLC and/or its affiliates ("Plexus", "we" or "us"), and govern your and our respective rights and obligations. The Terms constitute the entire agreement between You and Plexus relating to your Subscription. Please note that your use of the plexusworldwide.com website ("Plexus Website") is also governed by our Terms of Use and Privacy Policy, as well as all other applicable terms, conditions, limitations and requirements on the Plexus Website, all of which (as changed over time) are incorporated into these Terms. You can select the products and the monthly processing date for your Subscription order and there is no minimum purchase requirement. Plexus is committed to quality products for all its customers and wants to ensure your satisfaction. If You are not satisfied with your Plexus product purchase, You may request an exchange or refund within sixty (60) days of purchase by calling Customer Service at 480–9983490 and returning the unused portion of your product to Plexus at 9145 E Pima Center Parkway, Scottsdale, Arizona 85258. Only products purchased directly from Plexus by VIP Customers are eligible for exchange or refund. Refund or exchange amount is based upon the purchase price paid at the time of sale, applicable sales tax (if any) and shipping costs. Product refunds will be credited to the original method of payment in accordance with the <u>Plexus Returns Policy</u>. Replacement products supplied under this guarantee may not be returned.

We may, in our sole discretion, change these Terms, (including all applicable prices, terms, conditions, limitations and requirements on the Plexus Website), without notice to You. If any change to these Terms is found invalid, void, or for any reason unenforceable, that change is severable and does not affect the validity and enforceability of any remaining changes or conditions.
