

2022 Plexus Super Saturday Event Promotion

Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE CHANCES OF WINNING.

1. Eligibility

The 2022 Plexus Super Saturday Event Promotion (the “**Promotion**”) is open only to Plexus Brand Ambassadors who are legal residents of Canada (except Quebec) and the fifty (50) United States (including District of Columbia) who have reached the legal age of majority in their jurisdiction of residence at the time of entry. Void where prohibited by law. Employees of Sponsor and their immediate families and household members are not eligible and may not participate in this Promotion. The Promotion is subject to all applicable federal, state, provincial and local laws and regulations. Participation constitutes each entrant’s full and unconditional agreement to be legally bound by these Official Rules and Sponsor’s decisions, which are final and binding (without right of appeal) in all matters related to the Promotion to the extent permitted by law. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. Sponsor

3. Timing

The Promotion begins November 8, 2021 at 11:59 p.m. EST and ends December 15, 2021 at 11:59 p.m. EST (the “**Promotion Period**”). Sponsor is the official timekeeper for this Promotion.

4. How to Enter

Brand Ambassadors who register for the 2022 Super Saturday Event scheduled for January 15, 2022 between November 8, 2021 through November 21, 2021 with a \$14.95 USD entry fee will generate two (2) draw entries for the Brand Ambassador. Brand Ambassadors who register for the 2022 Super Saturday Event scheduled for January 15, 2022 between November 22, 2021 through December 15, 2021 with a \$19.95 USD entry fee will generate one (1) draw entry for the Brand Ambassador. All eligible entries will be entered into the random prize draw for all draws during the remainder of the Promotion Period.

All credit card payments must be in the name of the purchasing Brand Ambassador and not that of the sponsor or upline. Any declined eCheck payments will not generate a draw entry. Brand Ambassadors not in good standing under the Plexus policies and procedures are not eligible to participate in the prize draws. Neither purchases by Brand Ambassadors within 6 month of conversion date from a Brand Ambassador to Customer nor purchases by any Brand Ambassador Lead(s) received as part of the Plexus Leads Program will not generate eligible entries.

To obtain one (1) Entry in the Promotion without registering for the 2022 Super Saturday event, an eligible entrant may print his/her first name, last name, telephone number, complete mailing address, age and signature and send it to us.support@plexusworldwide.com. Upon receipt of your request in accordance with these Official Rules, you will receive one (1) Entry. To be eligible, all mail-in entries must be post-marked during the Promotion Period and received by no later than the day before the Draw Date (as defined below). The Released Parties (defined below) take no responsibility and accept no liability for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed mail-in entry requests. All Entries become the sole and exclusive property of the Sponsor and will not be returned.

All Entries are subject to verification at any time. Winner may be required to show proof (in a form acceptable to the Sponsor—including, without limitation, government issued photo identification) of being the Plexus Brand Ambassador associated with the selected Entry. All mail in Entries become the sole and exclusive property of the Sponsor and will not be returned.

5. Winner Selection

On December 17, 2021 inclusive in Scottsdale Arizona at approximately 12p.m. EST (the “**Draw Date**”), the Sponsor will select eligible Entries for the prize(s) described below in Section 8 in a random drawing. Two winners will be selected from the eligible Entries received. Prize winners will be announced on the Plexus Brand Ambassador Community Facebook Group. The winners will be contacted by email on the day of the relevant Draw and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these Official Rules). For any Draw the Sponsor may select additional winner(s) from eligible Entries its sole discretion. The Sponsor’s decisions as to the administration and operation of the Promotion and the selection of a potential winner are final and binding (without right of appeal) in all matters related to the Promotion. The selected entrants will be notified by email or phone on the Draw Date. Failure to respond to the initial attempted notification within two (2) days, or a return of any notification as undeliverable, will result in disqualification. Odds of winning a prize depend on the number of eligible entries received at the time of the selection.

7. Verification of Potential Winner

FOR CANADA, RESIDENTS ONLY: Before being declared as the confirmed prize winner, a Canada resident must first correctly answer a mathematical skill-testing question without mechanical or other aid (to be administered on the declaration and release). There will be two (2) prize winner(s) for the Draw for an exclusive 2022 Super Saturday Event Package. Each prize winner will receive (subject to compliance with these Official Rules) cash or goods as follows:

- Coach roundtrip airfare for winner and guest from winner’s closest major gateway airport;
- Hotel accommodations 2 nights and 3 days
- Ground transportation allowance of \$100 USD;
- Meal allowance of \$200 USD/per person;
- Friday night dinner, including photo and video opportunity.

The approximate retail value of the prize for the winner is \$3,000 USD.

No cash equivalent for non-cash prizes will be available. The Sponsor reserves the right to substitute the prize or a component thereof for any reason with a prize or a prize component of equal or greater value. For the United States, for the purposes of reporting your annual income to the IRS the value of any prize, award or offer, whether it be cash or non-cash is considered taxable income and will be included in the Form 1099-NEC if your total income from Plexus exceeds \$600.

9. Entry Conditions and Release

Each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final (without right of appeal) in all matters relating to this Promotion; (b) release and hold harmless the Sponsor and each of its respective parents, subsidiary and affiliated companies, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Promotion and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the “**Released Parties**”) from and against any and all claims, expenses and liability, including (except where prohibited) but not limited to, negligence and damages of any kind to persons and property,

invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Promotion, acceptance or use or misuse of prize and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Promotion and/or entrant's acceptance, use or misuse of prize.

Where prohibited the Sponsor will request winner's permission to use winner's name, likeness and/or photograph for promotional purposes.

11. General Conditions

To the extent permitted by law the Sponsor reserves the right, in its sole and absolute discretion and in consideration of the Entrants' interests, to cancel, suspend and/or modify the Promotion, or any part of it (including, without limitation, these Official Rules), if any fraud, technical failures or any other factor beyond the Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion, as determined by the Sponsor in its sole discretion. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In the event of any discrepancy or inconsistency between the terms and conditions of these Official Rules and disclosures or other statements contained in any Promotion-related materials, the terms and conditions of these Official Rules shall prevail, govern and control.

12. Limitations of Liability

The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (b) technical failures of any kind (including, but not limited to, malfunctions, interruptions or disconnections in phone lines or network hardware or software); (c) unauthorized human intervention in any part of the entry process or the Promotion; (d) technical or human error which may occur in the administration of the Promotion or the processing of Entries; or (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize. If for any reason an entrant's Entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another Entry in the Promotion, provided that if it is not possible to award another Entry due to discontinuance of the Promotion, or any part of it, for any reason, the Sponsor, at its discretion, may elect to hold a random drawing from among all eligible Entries received up to the date of discontinuance for any or all of the prizes offered herein.

Each entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Promotion, or any prizes awarded shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Promotion, or any prizes awarded, shall be resolved exclusively by the appropriate United States District Court in Arizona, USA or the appropriate Arizona State Court located in Maricopa County, Arizona, USA; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim proven, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. with, the laws of the State of Arizona, USA without giving effect to any choice of law or conflict of law rules (whether of the State of Arizona, USA or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Arizona, USA.
