 Promote Balance as a way to help minimize unwanted blood sugar spikes by slowing the speed at which carbs and sugars are digested, for a more steady release of energy into the bloodstream.*

- Share that Balance can help maintain healthy blood sugar levels already within a normal range to avoid that post meal crash.*
- Recommend Balance as a product that supports weight management by helping reduce calorie intake and reduce the glycemic index of carbs and sugars.^{^*}
- Promote Balance as a supplement to an otherwise healthy and balanced diet.
- Refer to how Balance is formulated with a blend of white kidney bean extract and mulberry leaf extract (help neutralize digestive enzymes that turn carbs and sugars into glucose), and cinnamon bark extract (polyphenols that help balance the endocrine system's hormonal response to food, helping maintain healthy blood glucose levels).*
- Share that Balance is gluten free, non-GMO, and vegetarian, and has no artificial colors.
- Share this product using only approved product claims, like:
 - "Supports weight management^*"
 - "Helps reduce calorie intake"
 - "Helps neutralize enzymes that turn carbs and sugars into glucose*"
 - "Reduces the glycemic index of carbs and sugars/helps minimize unwanted blood sugar spikes*"
 - "Reduces the negative effects of carbs and sugars by reducing the enzymes (alpha-amylase and alpha-glucosidase) that break them down*"



- Don't claim Plexus products can be used to treat, cure, or prevent any diseases or symptoms of disease, even if you don't actually name the disease, but use everyday terms (instead of medical terminology).
- Don't claim Balance is a substitute for a healthy and balanced diet.
- Don't claim Balance increases or gives you energy.
- Don't use the following "red flag" words or symptoms associated with illness or diseases: Anti-inflammatory, chronic fatigue, cholesterol, diabetes, heart disease, headache, heartburn, high or low blood pressure, inflammation, nausea, obesity, pain, and stomachache.
- Don't use testimonials about how Bio Cleanse affected a condition that would normally be treated with a drug or by a doctor. Personal experiences can be incredibly compelling, but they are regulated speech when used by the company. No matter how remarkable someone's personal experience may be, it could be a violation of U.S. regulations.
