

## **Plexus® February 2025 Canada Reset Challenge Giveaway – Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

### **1. Eligibility**

Plexus February 2025 Canada Reset Challenge Giveaway (the “Giveaway”) is open only to Brand Ambassadors and VIP Customers of Canada who are eighteen (18) years of age or older at the time of entry. Brand Ambassadors and VIP Customers must be in good standing under the Plexus policies and procedures. Void where prohibited. Employees of Plexus Worldwide, LLC and its respective parents, affiliates, subsidiaries, distributors, sales representatives, and all other service agencies involved with the Giveaway and members of their immediate family (spouse, parents, siblings and children) and household members (whether related or not) of each such employee are not eligible to participate or win. 2. Comment on the giveaway posts with an answer to the prompt and share a selfie of you on your current wellness journey.

#### **Entry Method 2.**

You will automatically be entered when you send an email to [kristina.ramcharran@plexusworldwide.com](mailto:kristina.ramcharran@plexusworldwide.com) with your name, address and phone number and your Brand Ambassador or VIP Customer membership number. Your entry will count for that day’s award in which your email is received.

Limit one entry per person per day regardless of method of entry.

You must follow the Plexus Canada Brand Ambassador Community group on Facebook at the time of entry and until the winner is finalized. You must have your Facebook profile settings as PUBLIC (not private) to enter your Submission. To participate in the Giveaway, if you do not already have a Facebook account, download the free Facebook application and create an account as instructed. Limit one entry per person per day and per Facebook account during the Giveaway Period. Use of multiple Facebook accounts to enter by the same individual is prohibited and may result in disqualification. Submissions will be deemed to have been submitted by the authorized account holder of the Facebook account from which the Submission is uploaded at the time of the entry, as identified by the primary email address associated with that account. ## **5. Winner Determination and Notification**

POTENTIAL WINNERS WILL BE NOTIFIED BY DIRECT MESSAGE ON FACEBOOK FROM PLEXUS CANADA STAFF AND WILL BE REQUIRED TO RESPOND WITHIN 72 HOURS OF NOTIFICATION. Failure by a potential winner to respond to any contact within the stated timeframe will result in disqualification, and Sponsor will select an alternate potential winner in the same manner. Odds

of winning a Giveaway prize depend on the number of eligible entries received during the Giveaway Period. Limit of one prize per person.
