

## **Plexus® March 2025 Golden Ticket Giveaway – Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

### **1. Eligibility**

Plexus® March 2025 Golden Ticket Giveaway is open to Retail Customer, Brand Ambassadors and VIP Customers of the fifty (50) United States (and the District of Columbia) who are eighteen (18) years of age or older at the time of entry.
