

Plexus® Jon Dorenbos Meet and Greet Giveaway— Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

Plexus® Jon Dorenbos Meet and Greet Giveaway is open to Retail Customer, Brand Ambassadors and VIP Customers of the fifty (50) United States (and the District of Columbia) who are eighteen (18) years of age or older at the time of entry. You must follow @One Plexus Community Facebook page or @Plexusworldwide Instagram page at the time of entry and until the winner is finalized. You must have your Facebook or Instagram profile settings as PUBLIC (not private) to enter your Submission.
