

Plexus Product Autoship Terms & Conditions

These are the terms and conditions of the Plexus Product Autoship Ordering Program ("Autoship") (the "Terms") 。 These Terms of Use are entered into between you (hereinafter referred to as "you" or "your") and Plexus Japan Co., Ltd. or its affiliates (hereinafter referred to as "Plexus") and govern the respective rights and obligations of you and Plexus. These Terms and Conditions certify the entire agreement between you and Plexus with respect to your Autoship. Your use of plexusworldwide.jp website (hereinafter referred to as the "Plexus Website") is governed by Plexus' Terms of [Use](#) and [Privacy Policy](#), and all other terms, conditions, restrictions and requirements applicable to the Plexus Website ("Terms of Use"). These terms of use, limitations, and requirements may be updated from time to time, as modified and incorporated into these Terms of Use. By placing an order through Autoship, you agree to the terms and conditions, restrictions and requirements. Please read these Terms of Use carefully.

When you select an Autoship product, the monthly processing date is automatically set. If you apply between the 1st and 15th of each month, the processing date will be the 15th of each month. If you register between the 16th and 31st, the processing date will be set to the 1st of the month. Unless you change the product of the Autoship order, the Autoship purchase information at the time of registration will be carried over to the next month. Customers should understand that the interval between shipments for each Autoship purchase is approximately one month. Plexus collects sales tax and shipping on orders based on the purchase price and shipping destination.

If you place an order for Autoship Purchase for the first time, Plexus will charge you with the credit or debit card or other payment method used to set up the purchase for that order ("Payment Method") and then automatically charge you for each month's Autoship purchase order based on your payment method. By agreeing to these Terms, you authorize Plexus to charge your payment method in accordance with these Terms.

The monthly autoship fee will be the same as the initial autoship order. However, this does not apply if you change your autoship order online through My Account. As you place your order, product prices, taxes, and shipping costs may change.

If you are unable to complete your payment with the payment method set up in Autoship, Plexus will update a different payment method from your My Account and you authorize Plexus to settle your Autoship order with that payment method.

If your order is out of stock at the time it is scheduled to be shipped, you authorize Plexus to fulfill your autoship order with a similar product that we believe will meet your expectations.

Your autoship will automatically create a new order every month until you cancel it, starting on the day you register.

Plexus may, in its sole discretion, terminate your autoship at any time without notice. In this case, you will only be charged for orders that have been shipped to you.

Your Autoship is for your personal use and may not be transferred or transferred to any third party without permission from Plexus.

Plexus is committed to delivering high-quality products that satisfy all of our customers. If you are not satisfied with the Plexus product you purchased, you can request a replacement or refund by contacting Customer Service (815068623692) within 30 days of purchase and returning the unused product to the address listed in the Help Center. The amount of the refund or replacement will be based on the purchase price paid at the time of sale, applicable taxes (if applicable), and shipping costs. Refunds for the product will be made to the original payment method [in accordance with Plexus' return policy](#). Replacement products provided under this warranty are non-returnable.

Plexus may, in its sole discretion and without notice to you, change these Terms (including all prices, conditions, restrictions and requirements applicable to the Plexus Website). If any modification of these Terms is held to be invalid or unenforceable for any reason, that change will be severable and will not affect the validity and enforceability of any remaining modifications or terms.

If you continue to subscribe after Plexus changes these Terms, you will be deemed to have agreed to the changes. If you do not agree to the changes, you must cancel the autoship.

Any dispute arising out of or out of this agreement or your autoship shall be subject to the exclusive jurisdiction of the Tokyo District Court.

These Terms shall be governed by and construed in accordance with the laws of Japan, and you agree to submit to the exclusive jurisdiction of the Tokyo District Court. Any dispute arising directly or indirectly from these Terms of Use or the Service Agreement shall be resolved with the exclusive jurisdiction of the Tokyo District Court.
