

**Plexus® 2026 Elevate Convention Golden Ticket Giveaway –  
Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. Eligibility**

Plexus® 2026 Elevate Convention Golden Ticket Giveaway is open to Brand Ambassadors and VIP Customers in Canada who have reached the legal age of majority in their jurisdiction of residence at the time of entry. Brand Ambassadors and VIP Customers must be in good standing under the Plexus policies and procedures. Void where prohibited.
