

# **Plexus® April 2026 Birthday Month Social Giveaway – Official Rules**

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

## **1. Eligibility**

Plexus April 2026 Birthday Month Social Giveaway (the “Giveaway”) is open only to Brand Ambassadors, VIP Customers, and Retail Customers of the fifty (50) United States (and the District of Columbia) who are eighteen (18) years of age or older at the time of entry. Brand Ambassadors and VIP Customers must be in good standing under the Plexus policies and procedures. Void where prohibited.
